who declared that it does, by these presence, hereby dedicate to the public for public use forever those streets and rights of way shown and depicted on the following surveys:

- 3) That survey prepared by Robert Lynn Davis, dated August 31, 2007, showing Oak Point Estates, Phase 3, which is filed and recorded at Map Slide 615B of the records of Natchitoches Parish, Louisiana.

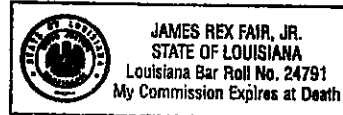
